## Driver Education Contract/ Registration form

### Requirements for Classroom/ Online Instruction (Only required for EOCST program)

- Complete the Virtual Drive Course(Online): If school doesn't offer, or student didn't take the Driver Ed class (Copy of Certificate when completed).
- Students of Hanover, Dover, & Spring Grove are the **only schools** that **KDS** can **administer** the driving test after 6 hrs of BTW training.
- Completed 30 hour classroom or other on-line course: Copy of transcript (grade/ report card)

### Requirements for Behind the Wheel

- A copy of a **valid Learner's Permit** must be submitted with the registration form: EOCST program.
- Minimum of a 24 hour notice of cancellation is required. A fee of **\$50.00** may be applied if school is not notified (case by case-life circumstance).
- Payment is required before instruction: If not, training could be canceled and/or a **\$50.00** fee may be applied.
- Must receive a **confirmation** via text/ email at least **24 Hour Notice** of scheduled time/ date.
- If no confirmation is received, the school (KDS) has the right/ obligation to cancel scheduled driving time and/or apply the cancellation fee.
- A certificate of Completion will be issued upon successful completion of the Driver Education (classroom/ 6 hours of BTW). The certificate may be submitted to insurance for a discount.

### Requirements for Instructional Driving and Pre-Test Driving

- Students must have a **valid permit or license**, and must meet all restrictions according to permit and license.
- Additional fee may be applied for training for additional travel time that's over 30 minutes.

### Notices:

1. Behind-the-Wheel: Payments can be **paid in full or in increments** before driving lessons (check or cash only).
2. A returned check will accrue a fee of \$50.00.
3. Krupinski Driving School (KDS) does not guarantee that a student will pass the PennDot driving test after completion of instruction.
4. KDS will not refund any tuition or part thereof, if the school has rendered services and has been willing, ready and able to fulfill its part of the agreement, and participant/ guardian didn't fulfill their part of the agreement due to cancellation or multiple cancellations prior to completion of the 6 hours of instruction.
